- Brendan do you have an idea of how you would like
- Jasmine it does say all bathrooms, but it think it would be helpful to list them. I
 would get a quote from the Pride Center

- e) Resolution on the impact of artificial intelligence tools on the University of Wisconsin-Green Bay, drafted by the University President and the Academic Affairs committee
 - Tanisha Are you saying no one can use Chat GTP for anything or do not write your whole essay with this?
 - 1. Harrison We should start designing assessments around this and not just testing things that could just be looked up. People are going to use these tools, so we should design our assessments to test thinking rather than retaining information. It is pro-chatGTP and using it responsibly.
 - Riley What is this intended to do? I see a lot of broad things, but I don't see what we are solving.
 - Harrison This is less about coming up with a solution, but saying we recognize
 that this is a problem. Faculty are aware of chat GPT but are unaware of how
 students use it. We are trying to give them info to work off of. The main action
 steps are that they communicate more with us.
 - Zea because it deals with more staff and facility, we could send an email to them
 because I don't know what a resolution would do. I think this could be an email or
 a press statement.
 - Harrison I just wrote this and sent it to the committee, if people think that is
 appropriate then we can do that. It may be good to do this. Resolutions for faculty
 are broader. I think it is worth putting in an official formal statement. If everyone
 thinks that that is a better idea, we could do that.



- Zea I don't know what student input could do.
- Harrison Do you want online proctoring? We need to open up the dialogue and teach those how to utilize it properly.
- Alex The document is very broad and should be edited or reworded. That being said I think Chat GTP can be a good tool, but perhaps this is not something we should take a stance on
- James it reads so broadly and I'm not sure what it is trying to say. It is not really
 proposing anything.
- Adam I have seen resolutions be broad like this such as eco ones. Oftentimes, if there are not action steps it gets filed away and never revisited.
- Ingrid We need to be proactive with this. This is very similar to when the internet came about and people were not ready for it. The same thing happened when everything went online during COVID. I think that we have a responsibility knowing that this is out there and the students are using it. We should keep this in this format. This isn't going away, it is only getting trickier. If we want to keep the university thriving, this is something we should be looking into.
- Ryan I met with a professor to see what things faculty members saw as student needs. One of the things she mentioned was Chat GPT. We need to generate interest within a group of people to advance. This might be effective if it gets to the right place.
- Erika I have never heard of ChatGTP. This is going to be letting the cat out of



the bag sort of thing. In my opinion, I don't think it should be released to students.

Students with dyslexia could have a disadvantage

- Jasmine how many people are aware of Chat GTP
- Harrison Within 12-18 months everyone will know about this. The research that I am seeing is that it is an advantage for students with grammatical skills. The tools get better every day. You are able to turn your ideas into words in a better way. It could help people to speak their ideas. We are going to need it when we leave school.
- Riley this is increasing at an exponential rate. In a year, everyone is going to be using it.
- Declan the IT department has talked about trying to ban it on university wifi and devices. I know someone who's professor brought it up and sent it out to the class.
 Don't use it to complete all your assignments, but you can use it as a learning tool
- Ingrid AI is all around us. We need to use it as a resource
- Logan one cool thing about AI is that it has really benefited speech to text. I
 think it might be worthwhile to have some sort of a disclaimer or
 acknowledgement. There is evidence to suggest that AI can reinforce bias by using
 a biased data set.
- Abby We can work on it in our committee meeting. Marketing departments are
 using chat GTP to bounce ideas off of it.
- Erika there are millions of other AI writers out there, if you're going to ban one



you need to ban the others.

- Maddie I don't think that this is trying to say that you need to use it, but it is going to be here.
- Harrison it sounds like there are a lot of action items that I will take. I also want
 to say that as a result of discussing this resolution with the teaching and learning,
 provost. They want to have a student advisory board on how to improve
 discussion. I am trying to put together a list of resources to try to teach how to use
 it correctly
- f) Constitutional review and amendment(s) led by Zach
 - Riley what is the point of the combined senate if we are still in USGA
 - 1. Zach it wasn't on the record, so I wanted to do that
 - Logan do they have voting rights?
 - 1. Zach Just the ability to sit on the committees
 - Adam I feel like it takes away power from exec which maybe is a goal and I am concerned that there could become an issue between exec and senate on the budget. I think the judicial aspect can help, can we put advisors in on it. SUFAC wants to be its own organization.
 - Riley RHAA is established by the SGA constitution
 - Adam what is our relationship and connection with RHAA
 - Zea you all elected us for a reason and I would have an issue with the court seeing as it is not as effective and it could be right now



- Riley I think that is a point against the court right now and not what it should be
- Jasmine it is the exec branch that nominates student court so you could argue that that is a bias
 - 1. Zach The execs can be fired by the president and the vice president. The justices cannot be removed. I could see it being stacked though
- Alex I think this is a good thing. I would like to see an advisor from the senate and sufac on the committee.
- Brendan There needs to be clarification on "internal budgets not approved"
- Jasmine couldn't they purposefully not come to an agreement
- Brendan The people in Senate have less of a reason to cooperate.
- Riley this was inspired by Madison's budgetary process. The senate is more representative of the student body than sufac.
- Harrison if the desire is to resolve the senate and exec dispute you could give the voting rights to both execs and senate
- Riley That is a good idea.
- Zea maybe we could improve on the current system and the budget needs to be discussed at senate meetings.
- Riley that would improve it, but we went over the budget last school year. The
 senate should vote because it would invite more discussion and give strong
 authority to the Senate to decide the budget.
- Adam when did budgets need to be due to sufac



- Riley end of december, but in this system it would be the hopes that SGA would start the budget very early on in the year
- Adam SGA is still considered a student org? Correct?
- Riley no SGA is not considered a student org and they are exempt from most guidelines. there is no expectation of viewpoint neutrality in SGA and that irks me
